

Rules for Special Awards:

BEST SIRE IN SHOW

To be awarded to the sire who has the highest number of horses in the top five of all qualifying classes.

BEST MALE IN SHOW

To be awarded to the male with the highest score in the qualifying classes.

BEST FEMALE IN SHOW

To be awarded to the female with the highest score in the qualifying classes.

BEST BREEDER IN SHOW

To be awarded to the breeder who has the highest score according to the system below:

- Marks will be attributed only to the Top Five as follows:

- 1st = 100 - 2nd = 80 - 3rd = 60 - 4th = 40 - 5th = 20

- In case of a tie, the result of the championship will be considered as follows:

- Gold = 50 pts - Silver = 30 pts - Bronze = 10 pts

The title of the Best Breeder for the same stud is awarded every two years

BEST HANDLER NATIONAL

The best local handlers will be chosen by the show's DC.

SCHEDULE

Management reserves the right to change the arena location of classes with prior notification to exhibitors. Show Management reserves the right to split classes with more than fifteen (15) entries. Show Management reserves the right to combine classes with adjacent age groups of the same sex if there are fewer than three (3) entries. Show Management reserves the right to change the dates and/or the location of the Show or to cancel the Show altogether. In the event of a cancellation, all entry fees and stall fees will be refunded (office fees are non-refundable). Neither Show Management nor the AHO shall have any liability to any exhibitor, owner, handler, or other person, firm, or corporation due to any change or cancellation of the show, except for the return of fees as mentioned above.

Family members below 21 will be included in the total count. However, a family member above 21 will be counted as an independent breeder. In case of an ownership change within a 1st degree family member (Father, Mother, Brother, Sister, Son, Daughter, Wife, Husband) over 21 years old, the change has to be conducted not later than the entry closing date

IDENTIFICATION OF HORSES

All horses entered in an AHO event must possess an official equine passport or a photocopy of the original registration document with a graphic description to facilitate the identity verification of the horse by the organizing committee and disciplinary committee. No announcement indicating the identity, breeding, or past performance of any exhibits, or the identity of the owners of the exhibits, may be made at any time prior to or during the judging of an entry. The name, age, breeding, breedership, and ownership of the entry may be publicly announced after the scores for that entry have been officially announced and/or posted.

IDENTIFICATION NUMBERS

Every horse entered in the show will be assigned an identification number (entry number) that **MUST** be worn by each horse handler (Exhibitor) when showing in a class.

AGE OF HORSES

To facilitate the division of entries into classes according to age, all horses shall be considered one (1) year older on the first day of January or the first day of October following the birth day of the horse according to the geographical region it belongs to in the organizing country.

RING PROCEDURES

If an exhibitor uses an incorrect number or does not have a number, this may be overlooked or the exhibitor may be excluded from the class based on the discretion of the show organizer. No one other than the employees, ring stewards, and officials in service may enter the show ring without permission from the show organizer.

GENERAL CONDITIONS

ADHERENCE TO AHO RULES OF CONDUCT

Organizing committee members, show officials, judges, trainers, exhibitors, and handlers will unconditionally submit themselves and their accompanying persons to the current show rules and accept the jurisdiction of the Arabian Horse Organization. Regarding veterinary matters, drug administration, and the misuse of banned substances, all show organizing committee members, show officials, judges, trainers, exhibitors, and handlers will unconditionally submit themselves and their accompanying persons to the jurisdiction of the International Equestrian Federation (FEI) and all the veterinary regulations upheld by the FEI.

The AHO shall not be liable for any consequences of any decisions made by show organizing committee members, show officials, judges, trainers, exhibitors, and handlers in conjunction with an AHO affiliated event. Show organizers are not permitted to introduce rules that conflict with the AHO "Show Rules."

REGISTRATION REQUIREMENT

- 1) A valid registration certificate or official correspondence from the governing National Registry indicating the completion of registration prior to the start of the AHO affiliated show must accompany the entry form for all show entries.
- 2) The "Registration Date" shall be defined as the date on which the appropriate WAHO-recognized registering authority for Arabian horses determines the horse (show entry) to be fully accepted for registration into the studbook of that country.
- 3) WAHO-recognized registering authorities for Arabian horses within each member country will have sole responsibility for determining the Registration Date.

ENTRY REFUSAL

The Show Committee reserves the right to refuse, accept conditionally, or cancel any entries of any exhibitor at their discretion. This refusal will be issued in writing by the Show Organizer.

Kind. The Judge shall be prohibited from adjudicating any entries by such Exhibitor for a period of six (6) months following the formal termination of the business relationship. Any Judge that fails to disclose any Conflict of Interest shall be suspended from officiating at any AHO show or event in ANY capacity for a period of 1 year from the date of the infraction.

The decision of the Disciplinary Committee shall be final if any doubt exists concerning any apparent Conflict of Interest.

Exhibitors MUST declare on all show entry forms any actual or apparent Conflict of Interest with any of the official Judges hired to adjudicate the event in question.

Show Organizers MAY NOT accept any entries for which any actual or apparent Conflict of Interest exists unless a reserve Judge is available to adjudicate on behalf of the Judge with whom the Conflict of Interest exists.

DISCIPLINE

Exhibitors are hereby cautioned that any act of discourtesy or disobedience toward the officials, whether by the owner, trainer, handler, groom, rider, family member, or any individual associated with those participating in the show, will result in the disqualification of the horse from adjudication. The management reserves the right to expel a trainer, handler, owner, groom, horse, rider, or associated individuals from the show without incurring liability for compensation or damages.

Excessive use of the whip on any horse in a stall, runway, schooling area, show ring, or anywhere else on the competition grounds, whether before or during a show, by any person, constitutes a violation and subjects the offender to penalties. Judges are expected to enforce this rule in the Show Ring.

Any actions taken against a horse by an Exhibitor, which are deemed excessive by a Judge, DC Member, Ring Steward, Veterinarian, or the Show Committee anywhere on the grounds, may result in the horse's elimination from the show.

It is a violation of AHO Rules to engage in any act or make remarks during the show that are considered offensive or made with the intent to influence or cast aspersions on the judging. Any Exhibitor found guilty of this offense may be barred from the show by the Show Committee.

PROTEST

Any Show Organizer, appointed Judge, or Ring Master may be excused or disqualified from the class at the discretion of the Show Organizer. No person other than the officials, Ring Steward, attendants on duty, and the Judge of the class may enter the show ring without permission from the Show Organizer.

CONFLICT OF INTEREST

An actual or apparent conflict of interest is explicitly defined as any of the following:

- a) A horse is judged that has been bought or sold by the judge either as an owner or agent.
- b) A horse is judged that is owned in whole or in part by the judge, a member of the judge's family, or a business partner in an Arabian horse business venture.
- c) A horse is judged that has been leased by the judge at any time.
- d) A horse is judged that has been bred by the judge or is the property of a breeding organization in which the judge is or was an employee.
- e) A horse is judged that has been regularly trained, examined, or treated by the judge in a professional capacity.
- f) A horse is judged that is the subject of an ongoing negotiation to buy or lease, or a provisional purchase condition to which the judge is a party.
- g) A Judge SHALL NOT be allowed to adjudicate any entries owned by, presented by, campaigned by, and/or showing under the name of an Exhibitor (BREEDER, OWNER, TRAINER, AGENT, LESSOR/LEASEE,

TRAINING CENTER, and/or STUD FARM) to/for whom the Judge has sold horses as AGENT, OWNER, BREEDER, LESSOR, and/or LEASEE within the six (6) month period prior to the commencement of the AHO Event at which the Judge will be officiating. It is the responsibility of the Judge to advise the Show Organizer and the Disciplinary Committee if such a conflict arises. Any Judge that fails to disclose any such conflict of interest shall be suspended from officiating any AHO show or event in ANY capacity for a period of 1 year from the date of the infraction.

h) A Judge SHALL NOT be allowed to adjudicate any entries owned by, presented by, campaigned by, and/or showing under the name of an Exhibitor (BREEDER, OWNER, TRAINER, AGENT, LESSOR/LEASEE, TRAINING CENTER, and/or STUD FARM) with which the Judge is knowingly involved in a profit-oriented business relationship of any nature.

VACCINATIONS

Vaccinations for all entries must be up to date and indicated on the entry form. Twelve (12) month vaccination intervals shall be considered standard, unless otherwise mandated by local/national authorities.

VETERINARIAN INSPECTION

At the discretion of the official Veterinarian of the show, all Horses with any apparent clinical signs of any disease are not allowed to participate in an AHO sanctioned event. Should the official Veterinarian diagnose apparent clinical signs of contagious disease, all subject horses will be immediately confined to quarantine and will not be allowed to participate in the show. All entry and stabling fees, as well as prize monies earned, will be forfeit.

DISGUIISING OF EXHIBITS

1) No alteration of the basic color of the skin, coat, or hooves is permitted. Hoof paints, colorless varnishes, coat dyes, glitter spray, and cosmetic operations, including skin grafts, are forbidden. Colorless hoof oils, Vaseline, oil, and white chalk used on white legs are permitted.

2) Artificial methods of dilating the eyes or affecting the natural action of the horse, or otherwise influencing its action or behavior by oxygenating the bloodstream, using weights or artificially weighted shoes, or by electrical or chemical treatment of any kind at any time before or during the exhibition are forbidden. Burns, cuts, or other marks on the body of any exhibit in such places or positions as indicate prohibited methods have been used will be regarded by the Disciplinary Committee, with veterinary advice, as full and adequate grounds for the exclusion of any exhibit from competition.

Exhibitors or owners of horses entered at the show may file a protest alleging a violation of AHO rules.

All protests MUST BE sent to the Arabian Horse Event contact in writing prior to the end of the show and presented to the Disciplinary Committee or sent to the AHO Secretary within five (5) working days following the conclusion of the show. The Disciplinary Committee is responsible for presenting a copy of the protest to the Show Organizer.

INDEMNITY AND NON-RESPONSIBILITY

All entries are accepted with the understanding that the World Arabian Horse Community will not be held responsible for any loss, damage or injury to any horse exhibited or any article of any kind. All horses shall be under the control and direction of the Show Committee but solely at the risk of the Exhibitor,

who will be responsible for any loss, damage or injury to any person, animals or property occasioned by him, his agents or employees, or by any animal owned or exhibited by him, and shall indemnify the World Arabian Horse Community against any and all loss, damages and liability thus occasioned, including, but not limited to, any and all legal costs, including attorney fees, which may be incurred as a result thereof. Exhibitors, grooms, handlers, owners, etc. are hereby warned that they may not use any device or conduct which may cause harm to any other person(s) horses, or equipment.

THE SUBMISSION OF A SIGNED ENTRY FORM TO THE SECRETARY SHALL CONSTITUTE AN ACCEPTANCE BY EACH PERSON OF THE PROVISIONS HEREIN SET FORTH.

DISPUTE NOT COVERED BY RULES

Should any question or dispute arise not provided for in the governing rules, the same shall be referred to the Show Committee, whose decision will be final.

- 1) A strike by the horse with the forelegs, with ears pinned back.
- 2) An aggressive attempt by the horse to bite.

All abuse and cruelty will be dealt with under AHO rules. Any horses that have been artificially, improperly, or unfairly prepared or tampered with before entering the Show Ring will be disqualified. If it is ascertained that an Exhibitor has made, or caused to be made, any false statements regarding any animal or article exhibited, or if any Exhibitor attempts to interfere with the Judge in the performance of his/her duties, they shall be excluded from competing or exhibiting.

Any trainer, owner, agent, or other person who administers, attempts to administer, instructs, aids, conspires with another to administer, or employs anyone to administer or attempt to administer a chemical or other irritant of any kind onto the anus, vulva, rectal area, or vaginal area of a horse entered to compete in a class for Arabian horses at any AHO affiliated event shall be subject to penalties as provided for in section (e) below.

A - The show organizer is authorized, at its own expense, to collect swab samples and test substances present on the anus, vulva, rectal area, or vaginal area of horses prior to their entry and/or following their exit from the ring in connection with any Arabian class at any AHO affiliated event as follows:

1 - The show organizer may choose all horses in such a class to be sampled or may select one or more placings from the class for sampling. The show organizer may act on the request of a judge of the class but is not required to do so.

2 - The show organizer shall appoint only a licensed veterinarian or veterinarians to supervise the sampling, and they may utilize technicians working under the direct supervision of the veterinarian(s).

3) In halter classes, horses may be fully or partially body clipped, but their eyelashes and the hair inside their ears should remain unshaven. Additionally, the hair on the muzzle, nose, and around the eyes must be intact. While balding around the eyes, nose, and muzzle is discouraged, judges should not overly penalize horses that exhibit such balding.

4) No equipment intended to alter the horse's natural appearance is allowed in the stables. This includes items like neck sweats, neck collars, tail racks, hobbles, or weights. The use of clippers is acceptable. The Disciplinary Committee (DC) will suspend exhibitors found using such equipment on the showground for the duration of the show.

SOUNDNESS

Horses must be sound, meaning they should not show any evidence of lameness. Horses that appear to be lame, displaying clear signs of pain, will NOT be assessed or placed by the judges. Judges are required to excuse from the ring any horse that is so lame that the assessment process would cause pain. Additionally, all entries must be in good condition.

STRESS

Horses must not be subjected to unnecessary or severe punishment anywhere on the showgrounds. This includes actions such as excessive whipping or shanking, overstimulation through noise or intimidation, the use of electrical shock devices, or any form of inflicting pain, and it is prohibited in all areas of the showground and stable areas at all times. Handlers who cause undue stress to horses anywhere and at any time on the showgrounds may receive Yellow and Red Cards from the Disciplinary Committee.

Undue stress is defined as:

- 1) Whipping or shanking horses when they are standing still.
- 2) Horses crouching or squatting while standing.
- 3) Horses falling to their knees after being presented with a whip.
- 4) Horses running or bolting backward three (3) or more steps.

Regulations will be enforced. Horses in competition will be subject to examination by the attending licensed veterinarian under the supervision of the Disciplinary Committee (DC) appointed at each AHO sanctioned event. The examination may include physical, saliva, urine, blood tests, the testing of eyes for the use of mydriatic drugs, or any other test or procedure at the discretion of the said DC necessary to achieve the purposes of this rule. These representatives must be treated with respect. Any exhibit may be tested at the request of any judge or DC. Regu-Mate® (altrenogest) may be administered to mares without penalty.

Refusal to submit a horse for examination, whether in competition or not, and failure to cooperate with the veterinarian and technicians until the samples have been taken, constitutes a violation of entry and subjects the horse to disqualification under the rules. Moreover, should the attending veterinarian designated to collect physiological specimens from any horse for the

purpose of drug testing deem the collection procedure may endanger the horse or the person(s) attending the horse, the DC will be notified and proceed with disqualification of that entry. In both cases, the disqualified horse will be ineligible to receive any awards, titles, and prize money or to compete further at the event in which the infraction occurred. Disqualification cases will be forwarded to the AHO by the attending DC.

DRUGS & MEDICATIONS MISUSE

The intentional or unintentional administration of any substance considered forbidden in accordance with FEI Veterinary Regulations, which may affect the performance, soundness, or temperament of any exhibit, is strictly prohibited at all AHO affiliated events. Each Show Organizer shall maintain an up-to-date copy of the FEI Veterinary Regulations listing all forbidden substances.

All procedures related to Drug & Medication misuse will adhere to FEI Veterinary Regulations, unless otherwise stated. If a positive result indicating the use of a forbidden substance is confirmed by the FEI authorized laboratory, the following steps will be taken:

3 - Chain of Custody Implementation by Show Organizer:

The Show Organizer shall implement the chain of custody required by the laboratory for identifying the horse from which each sample was taken.

4 - Sample Forwarding to Reputable Laboratory:

The Show Organizer is authorized to forward the samples for testing to a reputable laboratory acceptable to AHO. They shall also implement the chain of custody required by the laboratory for transporting the samples to and from the laboratory and while at the laboratory.

B - Submission of Samples by Trainer, Owner, and Agents:

The trainer, owner, and their agents of a horse competing in a class must promptly submit to the above sample collections performed by representatives of the Show Organizer. They must do so without unnecessary delays and cooperate with the sample collection personnel. Politeness, willingness to assist, and proper horse restraint during sample collection(s) are expected behaviors.

C - Reporting Presence of Chemical Irritants:

If the laboratory reports the presence of a chemical or other irritant of any kind in a horse's sample, the Show Organizer shall promptly forward to AHO the original copies of the laboratory report, the analytical data, and the documented chain of custody. This information is necessary to identify the horse from which the sample was collected and to confirm the laboratory results for that specific horse's sample.

D - Evaluation by AHO:

Upon receiving the above documents, AHO shall review them along with relevant competition and AHO records. A determination will be made as to whether this evidence serves as a basis for charges of rule violation against the horse's trainer, owner, and/or their agents.

E - Penalties for Violation:

In the event that AHO determines a violation has occurred, the trainer, owner, and/or their agents shall be subject to any and all penalties imposed by the AHO Standards & Ethics Committee at its discretion. These penalties may include suspensions, fines, and the revocation and redistribution of winnings. Notices of such penalties shall be published on the AHO website.

DRUGS & MEDICATIONS

The drugs and medication rules currently adhere to the most recent FEI Veterinary regulations and must be strictly followed on the showground. Verbal Warnings will not be officially recorded in the show report submitted by the Disciplinary Committee (DC). In case Verbal Warnings are ignored, further actions may be taken against horse handlers exclusively, following the protocol below:

a) Yellow Card:

A Yellow Card will be issued after a Verbal Warning if the initial Verbal Warning is ignored or if a further offense is committed. Additionally, a Yellow Card may be issued without a prior Verbal Warning if the offense is serious in nature and poses potential danger to horses and people.

b) Red Card:

A Red Card will be issued after a Yellow Card has been issued, provided the Yellow Card has been ignored or if a further offense occurs. In cases of serious mistreatment and/or reckless endangerment of horses and/or people, a Red Card may be issued without prior Verbal Warning or Yellow Card. Any handler issued a Red Card will be suspended from exhibiting any horses for the duration of the event during which the Red Card was issued. A replacement handler must replace the suspended handler for the duration of the class in which the Red Card was issued.

Yellow & Red Cards may be issued by all members of the Disciplinary Committee and/or Ring Stewards, both in the Show Ring and the Collecting Ring. Both cards are intended to serve as explicit public warnings that a serious offense has been committed.

DRUGS & MEDICATIONS

In the event of a positive test result for any forbidden substance, both the Show Organizer and the AHO will be promptly notified of the infraction. A positive test result for a forbidden substance shall be considered incontrovertible evidence of a rule violation. The official response by the AHO to this offense will be as follows:

1) The owner of the horse will be held fully liable for the infraction, unless irrefutable evidence implicating another person can be produced and substantiated.

2) All individuals involved in the administration of, and/or approval of the use of the forbidden substance, shall each be subject to a fine of five hundred euros (€500).

3) The disqualified horse will be barred from participating in all AHO sanctioned events for a period of twelve (12) months. Any titles and/or qualifications achieved by the horse at the event during which the forbidden substance was used will be forfeited. The details of the incident, including the name of the disqualified horse, the names of the suspended individuals responsible, and the specific forbidden substance used, will be published on the AHO website.

EMERGENCY TREATMENT

In the event of an emergency situation, any exhibitor or their representative may request the assistance of a veterinarian to treat an entry. Such treatment is categorized as "Emergency Treatment." Both the administering veterinarian and the attending exhibitor must sign a certificate detailing the reason for the Emergency Treatment. This certificate should be submitted to the Disciplinary Committee.

Emergency Treatments aimed at addressing lameness, colic, or any other severe injury or ailment are permitted on the showground. However, any horse that receives Emergency Treatment will be withdrawn from participating in the show. It is mandatory to report all Emergency Treatments administered on the showground to both the Disciplinary Committee and the Show Organizer. Please note that Emergency Treatments that may potentially affect the horse's performance are not permissible.

WARNINGS: VERBAL, YELLOW & RED CARDS

Verbal Warnings: Disciplinary Committee Members, Ring Stewards and/or Show Officials have the right to issue verbal warnings to handlers concerning behaviour towards and/or treatment to horses and/ or people anytime during the show anywhere on the Good or Satisfactory or Insufficient. The final score for Head/Neck will be the average of the two marks $(M2a+2bM)/2 = M2$.

Mark of Body and Topline : M3

The assessments proposed choices for Body and Topline are

- Excellent or Very Good or Good or Rather Good or Satisfactory or Insufficient or Poor .

Mark of Legs : M4

The judges will give separate marks : one for the front legs and one for the hind legs. The assessments proposed choices for Legs are :

M4a : Front Legs : Very Good or Good or Rather Good or Satisfactory or Insufficient or Poor

M4b : Hind Legs : Very Good or Good or Rather Good or Satisfactory or Insufficient or Poor

The final score for LEGS will be the average of the two marks $(M4a+M4b)/2 = M4$

Mark of Movement : M5

The assessments proposed choices for Movement are

- Ideal or Excellent or Very Good or Good or Rather Good or Satisfactory or Insufficient or Poor

For each aspect of the judged horses, the judge's assessments will be turned into marks according to the abovementioned assessment grid. The total score will be the average of the partial marks given by the judges. However to get a better homogeneity in judgment, each partial mark which will show a 1,5 pts difference from the average score will not be taken into account.

The total score for the horse will result from the addition of marks $(M1+M2+M3+M4+M5)$

Ranking will be made according to the final scores of the horses in the class : the horse with the highest score being first and so on.

SCORING SYSTEM

SCORING SYSTEM

The AHO established a scoring system based on principles aiming at guaranteeing some homogeneity in judgment as well as backing up the judges' decisions.

To evaluate horses the following rating system was adopted:

(20pts : Ideal)

(19 or 19,5 pts : Excellent)

(18 or 18,5 pts : Very Good)

(17 or 17,5 pts : Good)

(16 or 16,5 pts : Rather Good)

(15 or 15,5 pts : Satisfactory)

(14 or 14,5 pts : Insufficient)

(Below 14pts : Poor).

Thus each judge will choose the relevant qualitative assessment to evaluate each aspect of the horse.

Mark of Type : M1

The assessments proposed choices for type are

- Ideal or Excellent or Very Good or Good or Rather Good or Satisfactory or Insufficient.

Mark of Head and Neck : M2

This score will require separate assessments from the judges: one for Head and one for Neck.

This will allow judges to better assess each of the two parts.

M2a - Head : The assessments proposed choices for Head are :

- Ideal or Excellent or Very Good or Good or Rather Good or Satisfactory or Insufficient

M2b - Neck : The assessments proposed choices for Neck are :

- Ideal or Excellent or Very Good or Good or Rather

According to its final score, each horse will be defined as :

Ideal Horse More than 95 •

Excellent Horse More than 90-95 •

Very Good Horse Between 85-90 •

Good Horse Between 80-85 •

Rather Good Between 75-80 •

Satisfactory Horse Between 70-75 •

Insufficient Horse Less than 70 •

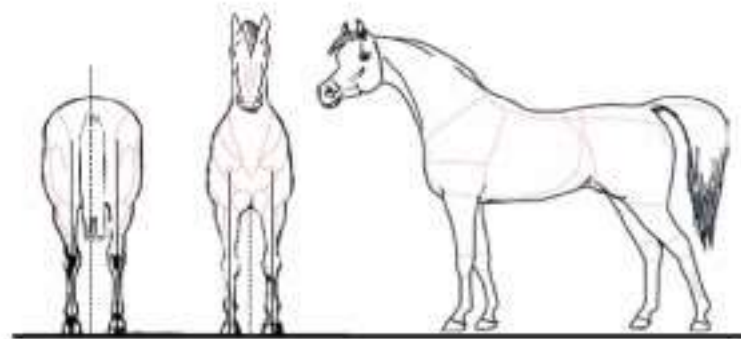

Here is an example showing how to calculate the final score :

The horses will then be classified according to the points obtained:

The Gold champion is the horse with the highest points score

The Silver champion is the horse with the second highest points score

The Bronze champion is the horse with the third highest points score.

RULES OF TIES

Tie in qualifying classes:

In case of a tie, the horse with the highest mark for Type will be nominated. If there is still a tie it will be the horse with the highest mark for Movement. Failing a decision in either of these 1 or 3 judges will be chosen by ballot and will name their preference.

Tie in Championships

The higher place will be given to the horse with the highest total in the qualifying classes. If there is still a tie, the rule for tie in qualifying classes will be applied.

CHAMPIONSHIP

- Yearling champions will be selected from qualified horses in different 1-year classes. A minimum of 2 classes is required to organize this championship.
- Junior male and female champions will be chosen from among qualified horses in the 2 to 3-year classes (or 1 to 3-year classes if there is no yearling championship).
- Senior male and female champions will be selected from qualified horses in the 4 years and over classes.

For each championship, qualified horses will include:

- The first three winner horses in each qualifying class.
- The remaining horses will be those with the highest scores, with a minimum of 17 points in Type and 75 points in the total score.

All judges will assess the championship unless there is a conflict of interest. Each judge will provide their own ranking classification, and marks will be assigned as follows:
